This Privacy Policy outlines the rules and regulations for the use of the Ozark Piecemakers Quilt Guild's website at <https://www.ozarkpiecemakers.com/>

Ozark Piecemakers Quilt Guild is a 501(c)(3) nonprofit organization. It is the Ozark Piecemakers Quilt Guild's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to <https://www.ozarkpiecemakers.com/> (hereinafter "Ozark Piecemakers Quilt Guild," "OPQG," "us," "we," or "<https://www.ozarkpiecemakers.com/>"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the website and does not apply to our collection of information from other sources.

This **Privacy Policy**, together with the **Terms and Conditions of Use** posted on our website, set forth the general rules and policies governing your use of our website. Depending on your activities when visiting our website, you may be required to agree to additional terms and conditions.

### **Website Visitors**

Like most website operators, OPQG collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. OPQG's purpose in collecting non-personally identifying information is to better understand how OPQG's visitors use its website. From time to time, OPQG may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

OPQG also collects potentially personally-identifying information such as internet protocol (IP) addresses for logged-in users and for users leaving comments on <https://www.ozarkpiecemakers.com/> blog posts (if applicable). OPQG only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

### **Gathering of Personally-Identifying Information**

Certain visitors to OPQG's website choose to interact with OPQG in ways that require OPQG to gather personally-identifying information. The amount and type of information that OPQG gathers depends on the nature of the interaction. For example, we may ask visitors who sign up for online access at <https://www.ozarkpiecemakers.com/> to provide a username and email address.

### **Security**

The security of your personal information is important to us, but remember that no method of transmission over the internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security.

## **Cookies**

To enrich and perfect your online experience, OPQG uses what is commonly known as "cookies" and other similar technologies provided by third parties to display personalized content and appropriate advertising in addition to storing your browsing preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. OPQG uses cookies to help identify and track visitors, their usage of <https://www.ozarkpiecemakers.com/> and their website access preferences. OPQG's visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using OPQG's website, with the drawback that certain features of OPQG's website may not function properly without the aid of cookies.

## **Links To External Sites**

Our service may contain links to external sites that are not operated by us. If you click on a third party link you will be directed to that third party's site. We have no control over and assume no responsibility for the content, privacy policies or practices of any third party sites, their products or services.

## **OPQG may use Google Ads or AdSense, Facebook, Bing and others for remarketing.**

The OPQG website may use remarketing services to advertise on third party websites (including but not limited to Google, Facebook, Instagram, and Twitter) to previous visitors to our site. It could mean that we advertise to previous visitors who haven't completed a task on our site, for example using the contact form to make an inquiry. This could be in the form of an advertisement on the Google search results page or a site in the Google Display Network. Third-party vendors, including Google, use cookies to serve ads based on someone's past visits. Of course, any data collected will be used in accordance with our own privacy policy and Google's privacy policy. You can set preferences for how Google advertises to you using the Google Ad Preferences page, and if you want to you can opt-out of interest-based advertising entirely by adjusting cookie settings or permanently using a browser plugin. If you choose to opt-out of cookies then you'll need to adjust the settings on each browser used including but not limited to Chrome, Firefox, Edge, Internet Explorer, Safari, and others.

## **Aggregated Statistics**

OPQG may collect statistics about the behavior of visitors to its website. OPQG may display this information publicly or provide it to others. However, OPQG does not disclose your personally-identifying information.

## **E-commerce**

Those who engage in transactions with OPQG are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, OPQG collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with OPQG. OPQG does not disclose personally-identifying information other than as described herein or in our Terms and Conditions of Use document. Visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Although most changes are likely to be minor, OPQG may change its Privacy Policy from time to time, and at OPQG's sole discretion.
