2. **Attach** a photo to your registration form, no smaller than 4" x 6". Photo is for identification purposes only.
3. All Non-Members of OPQG **must** complete and submit a Social Media/Image Release Waiver form.

5. Make checks payable to OPQG.
6. Mail registration form, photo, waiver, if needed, and entry fee to Mary Loker. OPQG members may also hand deliver form, photo, and entry fee to Mary.

**Quilt Shipping Guidelines:**

1. Ship quilt by FedEx or UPS to Mary Loker ensuring arrival no later than June 1, 2026.
2. You will be notified when your quilt is received.
3. If your shipping box will be used for return shipping, include a prepaid shipping label.
4. **Do Not** ship quilt to the Ozark Empire Fairgrounds E\*Plex address as it may get misplaced!
